## STEERING COMMITTEE FOR PARLIAMENTARY POLLS CONSTITUTED

**Shillong, March 19, 2004:** The West Garo Hills District Steering Committee as well as the Sub-Divisional Steering Committees for the forthcoming Parliamentary Elections 2004, were constituted at a meeting of all the political parties at Circuit House, Tura, on March 18, 2004. The meeting also discussed matters relating to observation of the Model Code of Conduct during the Elections.

The meeting was chaired by the Chief Electoral Officer, Tura Municipal Board and ADM in charge Law and Order, Mrs. S N Marak, who informed the representatives of the political parties that in order to ensure strict observation of the Code of Conduct, videography teams would be deputed to every locality and any violation thereof would be dealt with seriously. She cautioned the parties against misuse of official vehicles for electioneering purposes and also gave a briefing on maintenance of election expenditure.

The Steering Committee in West Garo Hills is to be headed by the Deputy Commissioner and Returning Officer, Mr. Shyam Jaganathan, as its Chairman, Mrs. S N Marak as its Vice-Chairman and Mr. W D Sangma, EAC as the Member Secretary. The members of the Committee include the Superintendent of Police, Mr. O Pasi, ADC in charge Ampati Civil Sub-Division, Mrs. P O A Sangma, ADC in charge Dadenggre Sub-Division, Mr. R P Marak and one member each from the political parties. In the Civil Sub-Divisions, the ADM in charge of the respective Sub-Divisions will be the Chairman and one EAC each as Member Secretary, along with a police official and a representative from each political party as members.

## **SECTION 144 Cr. PC PROMULGATED**

**Shillong, March 19, 2004:** In view of the information received that arms and ammunition are being smuggled into India from Bangladesh across the border of West Khasi Hills District with Bangladesh, for creating tension and insurgency in India, especially in the North Eastern Region by some persons/groups, the District Magistrate, West Khasi Hills District, Nongstoin, under Section 144 Cr.PC, has imposed night curfew from 9 P.M. to 5 A.M. within 500 metres from the International Border of West Khasi Hills District with Bangladesh.

Also in view of the General Elections to the 14<sup>th</sup> Lok Sabha 2004 schedule to be held on April 20, 2004, the District Magistrate has also prohibited the carrying of arms and other lethal weapons by members of the public, except security personnels on duty, in West Khasi Hill District so as to ensure peaceful, free and fair elections.

Both the orders shall come into force with immediate effect and shall remain in force until further notice.
